1. Call to order and roll call recording of members.
2. Motion and vote to approve a contract for legal services between Woodall Public Schools and Walta & Walta, Attorneys for serving as the board's legal advisor in administrative hearings before the board of education.
3. Due Process Hearing for Dr. Geary Crofford
 - A. The board president, or designee, will convene the hearing, state the purpose of the hearing, introduce the parties and administer an oath to all individuals who will testify. Upon the request of either party, the president may exclude from the hearing room the witnesses not at the time under examination. A party to the proceeding and his designee shall not be excluded.
 - B. Opening statement by superintendent or designee.
 - C. Opening statement by Dr. Geary Crofford or designee.
 - D. Presentation of superintendent's witnesses and evidence, followed by cross-examination of witnesses by Dr. Crofford or designee.
 - E. Questions by board members or board's counsel may be asked following the presentation of each witness.
 - F. Presentation of Dr. Crofford's witnesses and evidence, followed by cross-examination of witnesses by superintendent or designee.
 - G. Questions by board members or board's counsel may be asked following the presentation of each witness.
 - H. Presentation of rebuttal and surtebuttal witnesses and evidence, as necessary.
 - I. Closing argument by superintendent or designee.
 - J. Closing argument by Dr. Crofford or designee.


